


MESSAGE FROM THE DIRECTOR

Attendance: - 80 % attendance in theory and 100% attendance in practical with all the clinical

Requirements are compulsory for appearing in final examination.

Examination: Final exams will be conducted by HP Nurses Registration Council annually in the end of the session

Objectives:- under the aims of K.V.I.N. the following are the main objectives of the course. At the completion of the course the students are expected to:

- * Demonstrate competency in providing health care to individual, sick or well, using nursing process
- * Apply knowledge from the jumanities, biological and behavioral sciences in functioning as a nurse
- * Function effectively with members of the health team and community applying the knowledge of human relations and communication skills in her work.
- * Participate as members of the health team in delivery of curative preventive, promotive and rehabilitative health service.
- * Mobilize community resources and their involvement in working with the communities
- * Demonstrate use of ethical values in their personal and professional life
- ★ Demonstrate interest in activities of professional organization
- * Recognize the need for continuing education for professional development
- * Demonstrate basic skills in teaching patients and giving nursing care to them
- ★ Demonstrate basic skills in administration and leadership while working with other members of health team and community
- * Assist in research activities.

Eligibility:-

- 1. The age of the candidate should be between 17 to 35 years as on 31st December of admission year the upper age can be relaxable by 5 years in the case of SC/ST candidates. Age as recorded in the matriculation certificate will be entertained.
- 2. Minimum Education
 - a) 10+2 class preferably Science (PCB) & English with aggregate 40% marks from a recognized Board of School Education or its equivalent Board.
 - b) 10+2 in Arts (Mathematics, Biotechnology, Economics, Political Science, History, Geography, Business Studies, Accountancy, Home Science, Sociology, Psychology, Philosophy) and English Core/English Elective or Health Care Service Vocational stream only, passing out from recognized Board.
 - c) 10+2 Arts or Health Care Science Vocational stream only conducted by National Institute of Open School with 40% marks.
 - d) For SC/ST candidates, there will be relaxation of 5% marks.
- 3. Student should be medically fit. She should produce the fitness certificate duly issued by the chief medical officer/Medical Superintendent of the district.
- 4. Student shall be admitted once in a year.

- ➤ Have broad concept of the fundamental principles of the quality nursing care and demonstrate skill in providing nursing care to people of all age groups based on principles of physical, biological and behavioral science in an institute or in a community setting.
- Demonstrate leadership qualities and decision making abilities in various nursing situations.
- Participate as members of the health care team in promotive, preventive and restorative health care delivery system of the country.
- Demonstrate skill in teaching and supervising nursing care both in hospital and in community setting.
- Show knowledge on the latest trends and technology in improving the quality of nursing care.
- Recognize the need for continued learning and for personal and professional growth.
- ➤ Be self driven in evidence based research studies in various setting to improve the quality or nursing care.

Eligibility:-

- 1) The age of the candidate should be between 17 to 35 years as on 31st December 2 of the admission year. The upper age can be relaxable by 5 years in the case of SC/ST candidates. Age as recorded in the matriculation certificate will be entertained.

CAMPUS:-


LABORATORIES:-

Nursing foundation lab: This lab consists of modern equipments & dummies for the demonstration of nursing procedure. Lb is well equipped with all the articles required for various nursing procedures, so that student nurses can learn the procedures on manikins before doing them on patients in the hopital.

COMMUNITY HEALTH NURSING LAB:-

This lab is equipped with artificial rural & urban setting in which the student will learn about Indian rural & urban community & their problems. This lab is well equipped with articles for preparing student nurses to work in urban and rural communities. It has bags containing all the articles for community health nurses to perform various procedures during their home visits.











MATERNITY & CHILD HEALTH NURSING LAB

This lab help the student to demonstrate about normal & abnormal labor/delivery & child. Maternal and Child lab has beds with manikins and bedside cradles with new born dummies. There is a pediatric bed with a child dummy. It also has a delivery table and dummies for demonstration of labor. MCH lab is well equipped with various models for teaching students about stages of pregnancy.

NUTRITION LAB

This lab is well furnished & equipped with cooking facilities where the students learn preparation of various therapeutic & normal diets. Nutrition lab is well equipped with all kitchen articles for preparing and serving special diets to cater to the needs of patients suffering from Diabetes, Hypertension, Jaundice or Renal failure.

AUDIO VISUALAID LAB

This lab is equipped with high tech educational media to support the teaching learning activities of the nursing students. It has Multimedia projectors, over head projector, Slide projectors. There are flip charts. posters and transparencies on various topics related to nursing.

ANATOMY LAB

This lab has models on each body system. And articulated and disarticulated skeletons.

COMPUTER LAB

This Lab consists of latest computer with broad band facility that will help the students to get the latest information regarding diseases, treatment & their nursing care. The computer lab is spacious and well-planned with the latest hi-tech configuration of hardware and software. A computer lab has internet facility also.

TRANSPORTATION

Kol Valley Institute of Nursing has its own buses for picking up the students and staff from college to various destinations like Hospitals, Community centers, location of seminars, workshop or meetings etc. In addition to that Institute has light vehicles to provide quick conveyance to sick students to hospital when ever required.

OTHER FACILITIES:-

Clinical facilities

Clinical training is an integral part of the course and is imparted in leading and designated Hospitals of repute as approved by the State Govt. and we also have all kinds of laboratories where the students











demonstrate before placing for clinical training. College is attached with 270 bedded-Zonal Hospital, Bilaspur.

Vacation

Vacations are planned according to the INC rules. If the students are unable to return on time due to illness the Principal should be intimated immediately by telephone/email followed by a written explanation. On the return, they should submit a medical certificate issued by a registered medical practitioner stating full particulars of their illness and treatment. Normally, no other leave will be granted except the planned vacations. Students are not granted leave for social events in the family.

Extracurricular activities

In view of the main aim of education as the total deployment of the person, a number of opportunities are provided for the students to develop their skills and talents at various levels, through membership to the student and trained nurses associations and participation at local, state and national conferences and scientific exhibitions which promote leadership potentialities in the students. Beside these, opportunities to develop in music, dance, indoor and outdoor games and sports also provided.

Academic Progress and Clinical Evaluation:-

All students are expected maintain high academic and clinical stranded of performance through out the course. To this effect regular class tests are conducted every month and three sessional exam are also conducted, the average of these sessional exam are taken as the internal assessment marks which holds outmost importance in the final examination. Students who are repeatedly found not showing progress in the individual attention for improvement.

Examination

Final examination which includes theory and practical is conducted at the end of session.

Hostel

Hostel is the home for all the students who are living away from their homes. Our nursing students are housed in a secure separate girl's hostel. This makes the hostel an indispensable part of college infrastructure. The hostel is situated in the college premises. It is well furnished with modern amenities, Hygienic Mess, 24X7 water Supply & electricity. It is like home away from home form the students. Hostels have spacious furnished rooms. The constant presence of student-friendly wardens for guidance and counseling is a source of inspiration for the students who are away from parental guidance and support system.











HOSTEL RULES AND REGULATIONS

- Students are expected to display acceptable form of behavior and maintain discipline and decorum everywhere in general in and around the hostel complex in particular at all times.
- Ragging is considered as punishable offence as per regulations.
- Possession, distribution and consumption of alcoholic beverages, prohibited drugs and chewable tobacco are serious offence and strictly prohibited.
- Students are not allowed to leave the hostel without the permission of appropriate authority.
- Every care should handle hostel equipments, furniture and mess property carefully and should not damage it.
- Students are not permitted to use any electrical appliances (Heater, electrical rod, kettle etc.) in the hostel and if such material found from any student she will be fine accordingly.
- Students are responsible for all their personal and valuable belongings. They are expected to keep their
 valuables under their own supervision or under the lock and key, whenever they move out of their
 rooms. In case of loss of any such belongings whatever, the college will not be responsible and no claim
 will be entertained in this regard.
- Students will not be allowed to entertain their parents/ relatives/ friends during institute hours and also in the hostel.
- Fan and lights should be turned off before leaving room.
- Visitors are not allowed in the students rooms. Visitors are allowed to meet them after 4:15pm 6:00pm in working day and on holiday from 8:00am 5:00pm
- Time to report back from outing to hostel is 5:00 pm.
- Students are allowed to follow strict study timing i.e. 5:30pm 8:00 pm. Students are not allowed to use cell phones during study period and it must be kept switched off during study period. Students are not allowed to use their phone after 10:30 pm onwards.
- If any student has to go to the outside the hostel for any work, she must write the purpose, place, time of leaving and time of return in the register with the security guard on duty.
- All communications regarding any problem of a student or any other hostel problem must be routed through the warden or hostel incharge teacher. A proper channel must be foolowed to report any incident or issue in the hostel.
- The institute timings are 9:50 am to 4:10 pm. Students are not allowed to stay in the hostel during the class hours unless the stay is unavoidable due to illness or any other valid reason. The In such cases CR should take the permission and communicate the information to the coordinator in writing.
- Day Scholars are not allowed to enter the hostel.
- No students should be found outside the hostel after attendance. Those who are having there clinical duties should come directly to the hostel after taking their meals.
- No hosteller is permitted to take food in the room except for those reported stick with prior permission of hostel warden.
- All the students should follow the strict mess timings. No student shall be allowed to take meal after this timing. Those who are on clinical duties can take their meal according to their duty shifts.
- If student is sick she should take rest in the sick room and if they are taking meal from the mess then should return back the utensils to mess. It should not be kept in the sick room.
- Modification or addition of rules may be made and communicated as and when necessary.

RAGGING

RULES AND REGULATIONS ANTI RAGGING:-

What is Ragging

Ragging is totally prohibited in Kol Valley institute of nursing inside and outside the campus and anyone found guilty of ragging and abetting ragging whether actively or passively, or being a part of conspiracy to promote ragging, is liable to be punished under the provisions of any penal law for the time being in force.

- Ragging has several aspects with among others psychological, social, political, economic, cultural & academic dimensions.
- Any act that prevents, disrupts or disturbs the regular academic activity of a student should be considered within the academic related aspects of ragging, similarly exploiting the services of a junior students for complicating the academic related ragging prevalent in many institution particularly in the technical institutions.
- Any act of financial exortion or forceful expenditure burden put on a junior student by a senior student should be considered an aspect of ragging for economic dimensions.
- Any act of physical abuse variants in sexual abuse, homosexual assaults, stripping, fore absence and lewd act, gestural, causing bodily harm or any other danger to health or person can be put in category of ragging with criminal dimensions.
- Any act of abuse by spoken words, emails, snails-mails, blogs, public insults should be considered with in psychological aspect of ragging. Any act that affects the mental health & self confidence of student also can be described in term of psychological aspects of ragging.
- The human rights perspective of ragging involves the injury caused to the fundamental rights to human dignity through humiliation heaped on junior students by seniors, often resulting in the extreme steps of suicide by the victims.

Action in Event of Ragging :-

- 1. The institution shall punish a student found guilty of ragging after following the procedures and in the manner prescribed here in under:
- The anti-ragging committee of the institution shall take an appropriate decision, in regard to punishment or otherwise depending on the facts of each incident of ragging and nature and gravity of the incident of ragging established in the recommendations of the anti-ragging squad.

The anti-ragging committee may depending on the nature and gravity of the guilt established by the anti-ragging squad, award, to those found guilty, one or more of the following punishments, namely

- (a) Suspension from attending classes and academic privileges
- (b) Withholding/withdrawing scholarship/fellowship and other benefits
- (c) Debarring from appearing in any test/examination or other evaluation process
- (d) Withholding results
- (e) Debarring from representing the institution in any regional, national or international meet, tournament, youth festival etc.
- (f) Suspension/expulsion from the hostel
- (g) Cancellation of admission
- (h) Rustication from the institution for period ranging from one to four semesters
- (i) Expulsion from the institution and consequent debarring from admission to any other institution for a specified period. Provided that where the persons committing or abetting the act of ragging are not identified, the institution shall resort to collective punishment.

An appeal against the order of punishment by the anti-ragging committee shall lie, (i) in case of an order of an institution, affiliated to or constituent part, of a university, to the vice-chancellor of the university. (ii) in case of an order of a university, to its chancellor (iii) in case of an institution of national importance created by an act of Parliament, to the chairmen or chancellor of the institution, as the case may be.

Where in the opinion of the appointing authority, a lapse is attributable to any member of the faulty or staff of the institution, in the matter of reporting or taking prompt action to prevent an incident of ragging or who display an apathetic or insensitive attitude towards complaints of ragging, or who fail to take timely steps, whether required under these regulations or otherwise, to prevent an incident or incidents of ragging, then such authority shall initiate departmental disciplinary action, in accordance with the prescribed procedure of the institution, against such member of the faulty or staff, Provided that where such lapse is attributable to the Head of the institution, the authority designated to appoint such Head shall take such departmental disciplinary action and such action shall be without prejudice to any action that may be taken under the penal laws for abetment of ragging for failure to take timely steps in the prevention of ragging or punishing any student found guilty of ragging.
